2025 RENEWAL & DUES NOTIFICATION

Dear TCC Member(s):

Where does the time go?? 2024 is in the books and 2025 is in full swing!

We are happy to report that despite continued inflation, WE WILL NOT BE RAISING DUES THIS YEAR!! Our Board of Directors have been hard at work during the off-season meeting with Councilman Marion Edwards to secure a grant that other clubs in our District received earlier in 2024. We are thankful and beyond excited to announce that we have entered into a Cooperative Endeavor Agreement with Jefferson Parish for a grant which will assist us with funding much needed improvements and repairs at the club. The grant is on a reimbursement basis, but it's exactly what the club needs to return the club to its former glory. When the club opened over 50 years ago, there was a waiting list to join and our club was one of the hottest commodities on the Westbank. Keep in mind that Terrytown Country Club is still one of the most affordable clubs in Metropolitan New Orleans and we hope that the planned improvements will make membership even more attractive.

Our dues will remain as follows: Single membership \$500.00; Stockholders \$600.00 (which includes the \$100 assessment); Family \$725.00; and Athletic \$225.00.

Last year we began accepting PayPal payments which we will continue to do. We are also working with the bank to offer ACH payments for anyone who would like to split their payments over several months. In order to split payments, you will be required to execute an ACH Agreement/Authorization. Even with an ACH Authorization, payment of dues must be completed by June 1, 2025. If you are interested in splitting payment for your dues, please complete and return the attached ACH Authorization.

As we have for the past several years, everyone who returns their renewal early (paid in full) by February 28, 2025, will receive a complimentary guest pass card (5 visits) which is valued at \$50.00. We will continue to offer discounted guess pass cards for sale and the price will also remain the same, \$80.00 for a card of 10 guest passes - \$8.00 per guest fee (guest fees are \$10.00 at the gate). Please see a manager when we open to purchase your passes.

If you know of someone who is interested in membership, please forward them a copy of the application which is also available on the website terrytowncountryclub.com. Except for a few fundraisers, membership dues are our only source of revenue, so, please encourage your friends and family to join. Please also keep in mind that all new applicants must be sponsored

by current members in good standing of the club and are subject to Board approval. Please take a minute to review our membership guidelines and application process - returning members do not need sponsors.

For accuracy in accounting, record keeping and insurance purposes, we ask that **ALL** members complete the application/renewal form and return the completed application along with payment prior to May 1, 2025. Dues paid after May 1st are subject to a \$25.00 late fee unless you have entered into an ACH Agreement. Remember, we can also accept PayPal and credit card payments, but a small transaction fee applies. If you would like to pay by credit card, please complete the enclosed credit card authorization. **Please be sure to include your e-mail address on the application, this will assist us in communicating with your family.**

We continue to have one of the best summer swim programs in the area and are excited about our Swim Program for 2025 with Brigette Murphy at the helm again! Keep an eye on your email and the club's website for details on Swim Team registration date and time. Swimmers must be ages 4-18 by 6/1/25. We will announce the sign up date so that you can come in to register and meet our Coaches. We are also happy that Scott Robinson remains a part of the Terrytown Country Club team. Scott came to us with extensive experience as a tennis pro in the New Orleans area and has extended his talents to pickleball. Membership Category Definitions

Stockholder Membership: Membership for one adult, spouse and dependent children younger than 26 and residing in the same household with guest privileges.

Family: Membership for one adult, spouse and dependent children (younger than 26) and residing in the same household with guest privileges.

Single Adult Membership: Membership for one adult with guest privileges.

Athletic Membership: Ages 12 - 18, no guest privileges (please see additional requirements for Athletic Membership) Applications for Athletic membership status must also include:

- Proof of age in the form of a valid Birth Certificate.
- Parent's or Legal Guardian's permission signature.
- Participation on club sponsored athletic team, must participate in 3 swim meets
- Payment in full of all fees in connection with participation on club sponsored athletic team.

Guidelines for Membership Admission

The following guidelines will be utilized by the Membership Admissions Committee in determining the qualification of an applicant for membership.

Application:

A membership application form must be submitted for review by the Admissions Committee for completeness and accuracy.

- Letters of recommendation from two current Terrytown Country Club members in good standing, one being a charter member (stockholder). These letters must accompany the application.
- The application must be signed and dated by the applicant.

Application Process

All new membership applications are reviewed weekly by the Membership Admissions Committee from March 1 – May 1. Each new application will be reviewed by the Membership Admissions Committee. Applications for new membership should be accompanied by a letter of sponsorship from two sponsoring members (one charter/stockholder member sponsor required). Any application received without charter member sponsorship must be interviewed by the Membership Admissions Committee.

Results of the interview will be documented by the Membership Admissions Committee and included as part of the recommendation submitted to the Board of Directors for final approval.

The Membership Admissions Committee will maintain a current list of qualified applicants in the order each applicant is determined to be qualified, subject to subsequent actions by the applicant when contacted about their membership application.

Board of Directors Review of Membership Applications

The Board will review membership applications presented to them for consideration by the Membership Admissions Committee and will consider the recommendation of that committee. All applicants are subject to background check and verification of information provided on their application. There will be no discrimination based upon race, religion or sex in the review of applications.

Additional Information:

Membership dues and fees are subject to change at any time.

1. Annual dues shall become due on May 1st of each year.
2. Dues and entrance fees are payable upon acceptance of Membership invitation.
3. Membership shall become effective only after all payments have been made or in accordance with a schedule approved by the Board of Directors.


